Application for Appointment to Mercer Island City Council Position #1 From Tana Senn

1. Why are you interested in serving as a Mercer Island City Councilmember?

Public service and policy have always been a part of my life, as reflected in my education, career path and volunteerism. This City Council opportunity comes at a perfect time when I have chosen to focus on my family and my community. I strongly believe in showing my children the importance of getting involved and making a difference for the community in which we live. I believe my perspective, as a woman with young children, is an important one to have on our City Council.

2. What strength would you bring to the Council?

My Master in Public Policy and Administration has been a strong foundation for my years of policy, communications, service and advocacy. I have worked in many team environments, which require a strong ability to listen and gather facts and then, in concert with my strong personal convictions, make decisions. The following are examples of where I have put these skills to action:

- As a facilitator, I lead broad-based community planning sessions for the city of St. Louis, MO
 during development of their application to be a federal Empowerment Zone. I worked with
 business leaders, unions and community organizers to generate public-private partnership
 projects and agree upon clear, tangible goals for the city.
- As a consultant for The Seattle Foundation, I worked closely with their leadership team to develop
 the concept and generate A Healthy Community, a 96-page report to help donors zero in on
 philanthropic opportunities that would leverage their dollars to the greatest extent.
- As a community leader and volunteer, I served for many years on the board of the largest, local Jewish organization, grappling with financial, political and other governance-related issues.

3. What are the three highest priorities and/or issues you believe the City needs to address? How would you propose to address these issues?

- <u>Budget</u>: The City Council has made some difficult decisions with the 2011-2012 budget. We need to monitor the implications of the cuts, being mindful to maintain our community's core values. At the same time, we need to consider the slowly improving economic climate and voters' willingness to support bonds or levies for schools, a new pool and/or a new south end fire station that may be needed over the next few years. Additionally, as the population of the Island grows in north end apartments, we may need to explore ways to cover the associated costs of services since property-related taxes are not the main revenue generated from this population.
- Education: Our growing population of children and reduced public funding are challenges our schools are facing and will continue to face in the years to come. As class sizes increase and teacher pay decreases, we need to maintain our (rightly earned) reputation for stellar public schools, in part to ensure our property values and resulting tax base remain strong. Additionally, as our schools exceed capacity and age further, the City will serve as an important partner as the school district implements its 21st Century plans.

- Transportation: From commuting times and parking to road sharing and safe routes to school, transportation is a major issue for our Island. As we plan for light rail, we must anticipate the parking needs and implications for Mercer Island, looking for ways we can maximize resident access and minimize traffic. As we continue to maintain our streets, let's examine where we can, at the same time, make them safer so kids have the option to safely walk to school. Undoubtedly, there will be traffic and safety implications for the entire corridor around the North Mercer Campus as that property is developed over the coming years. Anticipating and addressing these concerns early on will be an important City role.
- 4. Explain your current and past community involvement and/or service on city, nonprofit, or public boards, committees, task forces, or commissions and how this has contributed, and is relevant, to the Mercer Island community.
 - Mercer Island Issues: From grassroots advocacy to writing articles for the Mercer Island Reporter, I have consistently shared my voice to better our community. I have lobbied in Olympia on education issues important to our schools and am involved with the PTA legislative committee. When many of our schools were tagged with hate speech graffiti this past fall, I was outraged. Together with a friend, we gathered more than 40 Island residents at Island Crest and 40th during Yom Kippur to show our support of the diversity of our Island and of the Jewish community. And, as a mother and resident living in the middle of the Island, I felt it was important to actively support safety improvements along Island Crest Way.
 - Jewish Federation of Greater Seattle: For 10 years, I have been deeply involved with the Jewish
 Federation of Greater Seattle, a nonprofit that raises \$6 million annually. I served with many
 other MI residents on their Board of Directors and Government Affairs Committee and then as
 the professional Marketing and Communications Director for two years. As the Government
 Affairs Chair, I helped lead the Jewish community's efforts to support state funding for human
 services for the needy, abused, and elderly.
 - Additionally, and unfortunately, I have crisis management experience. Immediately after a deranged gunman killed one and injured five others at the Jewish Federation in 2006, I served on the team that led the organization through its first weeks of recovery. I continued to serve as the media liaison all the way through the second trial of the gunman four years later. This crisis led to the strengthening of security for Jewish institutions including the Stroum JCC and the NW Yeshiva High School on Mercer Island.
 - Graduation Book Drive: Earlier this year, together with two other Mercer Island moms, we started
 the "Mercer Island Graduation Book Drive," benefiting young children in need. During the
 weeklong drive, we collected more than 4,000 early reader books from families at the local
 elementary and nursery schools and at Island Books. Garnering numerous partners in the effort
 was a successful model and the impact of these books for families in need shows the power of
 Mercer Island volunteerism and what we can accomplish together.

5. What do you wish to accomplish during this appointed term as a Mercer Island City Councilmember?

As a new City Council member, I look forward to:

- Establishing close working relationships with my fellow Council members to best address issues that come before our body.
- · Monitoring difficult budget decisions to make any mid-stream adjustments, if needed.
- Starting initial planning for major community discussions and City action around light rail parking, the potential redevelopment of the North Mercer Campus, the pool, and the south end fire station.

6. What is your vision for our City and community?

I would like to see Mercer Island manage its growth such that we maintain our small community feel, while benefiting from being a part of this diverse region. We must acknowledge, embrace and properly address issues arising from a growing population even as we ensure that treasured community traditions--such as American flags along Island Crest Way for the 4th of July, Mostly Music in the Park, Pioneer Park, high-quality schools--continue. I envision a City that makes decisions that support the very quality-of-life reasons many residents moved or returned to the Island: a safe, welcoming place for new and multi-generational families, parks and open spaces, quality education and accessibility to jobs.

7. Is there anything else that you may wish to add that would help us get to know you a little better? My family and I have lived on Mercer Island for nearly six years. My husband Kevin and I have two children at Island Park, who both attended Country Village Day School. They have played sports and attended camps at the MIBGC, JCC and through Parks and Recreation. We belong to the Mercer Island Beach Club and are quite involved in the Jewish community. My husband Kevin is an executive at a wireless Internet company.
